MODEL ELECTION GUIDELIENS OF RAJASTHAN STATE BALL BADMINTON ASSOCIATION

Name of the Association: RAJASTHAN STATE BALL BADMINTON ASSOCIATION

Election of office Bearers and Members of Managing committee, Rajasthan State Ball Badminton Association Election Bye-lows

1.Short Title & Definitions

- (1) These bye-laws shall be called the 'Election Bye-laws' and shall govern the conduct of office bearers and members of Managing Committee of Rajasthan State Ball Badminton Association (RSBBA).
- (2) In these Bye-laws, unless the context otherwise requires, -
 - (a) 'clause' and 'sub-clause' mean the clause and sub-clause of these Bye-laws;
 - (b) Managing members' means Member of managing Committee of Rajasthan State Ball Badminton Association.
 - (c) 'Form' means the Form appended to these Bye-laws;
 - (d) Rajasthan State Ball Badminton Association. means Name of the Association;
 - (e) 'post includes the office of President, Secretary, Treasurer, Vice President, Joint Secretary and Member of Managing committee of Rajasthan State Ball Badminton Association.
 - (f) 'Rule' means the rule of rules and Regulations of BBFI/Sports code.

2. Managing Committee:

(1) The 11 (Eleven) office Bearers Shall be as follows: -

1	President	1 (one)
2	Vice-President	4 (Five)
3	Secretary	1 (one)

- 4 Treasurer 1 (one)
- Joint Secretary 4 (Five)

3. Manner of Election:

- (1) Office Bearers and Members of Managing Committee of Rajasthan State Ball Badminton Association shall be election by secret ballot.
- (2) Election shall be held at the Special General Body Meeting (SGM) in accordance with the procedure prescribed hereinafter, from amongst the Representatives of the Districts Member.

4. Electoral College:

- (1) Each District Member duly affiliated by Rajasthan State Ball Badminton Association (abbreviation of Association) as its District member shall have one vote at the elections of the office Bearers and Managing Committee Member.
- (2) For the purposes of sub-clause (1), each District Member.
- (3) District shall be represented by one members authorized by the president or Secretary of the affiliated District Member, however, in case President/Secretary nominates different person (s), the Person (s) authorized by the President/Secretary shall be deemed to be the duly authorized person (s). Irrespective of the date.

Each District Duly affiliated by as its District member under shall be represented by only one representative.

- Each District Member intimate the name(s) of their representative(s) mentioned in subclauses (2) and (3), latest by 20.09.2018 and such intimation shall be addressed to the General Secretary/Election Officer of BBFI, on their letter head duly signed by President/ Secretary of that member Distt., so as to reach him on or before the aforesaid date; ant change in the name of any authorized representative after 20.09.2018 or any intimation received thereafter shall be permitted only with the approval of the Election committee and Election officer.
- The General Secretary of BBFI shall prepare the list of the authorized representatives of the member District in Form 1, and circulate a copy of the list so prepared by him to all member District, latest by <u>04.09.2018</u> by display, on the website of BBFI.
- The General Secretary of BBFI shall also furnish a duly authenticated copy of the list mentioned in sub-clause (5) to the Returning Officer as soon as may be after his appointment by the BBFI under clause (5) below.

6. Returning Officer:

As soon may be before/after the issue of the notice for the Special General Meeting (SGM), the BBFI shall nominate a person as Returning Officer for conduct of Officer Bearers and member of Managing Committee RSBBA, in accordance with the Provisions of these Bye-lows.

7. Nomination of Candidates:

- (1) The nomination of a candidate for election as office Bearer or Member of Managing Committee shall be made in Form 2.
- (2) The nomination of candidate for election as Office Bearer or a member of Managing committee shall be proposed by one of the representatives of Member District whose name is included in the Electoral College list in Form 1, and also subscribed by 1 (one) such representative as seconder.
- (3) Each candidate shall be entitled to be nominated by not more than 2(two) nomination papers.
- (4) Each Nomination paper shall be Delivered Personally to the Returning Officer in paper by the candidate himself/herself from <u>13.09.2018</u> to <u>23.09.2018</u> between <u>11.00 AM</u> to <u>7.00 pm</u>.
- (5) No person shall be eligible to nominate more than one candidate for the same post, either as proposer or seconder, and, if he so Does, his/her signature on the nomination paper Delivered second in point of time to the Returning Officer shall be Deemed to be inoperative.
- (6) No person shall be permitted to withdraw his/her name as proposer/seconder, once the nomination paper subscribed by him/her has been delivered to Returning Officer.
- (7) As soon as may be after <u>7.00 P.M. on 23.09.2018</u>, the Returning Officer shall prepare a list of all nomination received by him, post wise, in Form 3; and publish the same in a conspicuous place in his Office.

8. Scrutiny of Nomination:

- (1) On 24.09.2018, at 12:00 noon,
- (2) The Returning Officer in his Officer shall scrutinize each nomination paper, one by one, received by him, and determine its validity or Otherwise.

- (3) At the scrutiny of nomination, each candidate or one of his authorized representative shall have the right to be present and raise any objection in relation to nomination of a candidate for the post for which he/she has filed his nomination.
- (4) As soon as may be after the scrutiny of all nomination paper has been completed by him, the Returning Officer shall prepare list of validly nomination candidates in Form 4 and the Contesting Candidates can take a copy from the Returning Officer.

9. Withdrawal of candidates:

- (1) Each candidate whose nomination has been found valid on scrutiny shall be entitled to withdraw his/her candidature, from 24.09.2018 to up to 7.00 P.M. of 27.09.2018.
- (2) Notice of withdrawal of candidature shall be submitted in Form 5, either by the candidate himself/herself or by a person duly authorized by him/her in writing.
- (3) Notice of withdrawal of candidature shall be final and shall not be allowed to be cancelled.
- (4) The Returning Officer shall accept the notice of withdrawal if her id satisfied as to the genuineness of the notice.
- (5) As soon as may be after 7.00 PM on the <u>27.09.2018</u>. The Returning Officer shall prepare the final list of contesting candidates in Form 6, and display a copy of the said list in conspicuous place in his office on <u>27.09.2018</u> and on BBFI Website. And also furnish a copy of the same to each of the candidates/their authorized representatives, if they so demand.
- (6) The names of the contesting candidates in Form 6 shall be arranged, for each post, in alphabetical order according to English alphabets.

10. Uncontested Returns; and Contested Elections

- (1) Where the number of contesting candidates for any post or category of post, in Form 6 is equal to the number of posts to filled, all such contesting candidates shall be deemed to be duly elected unopposed to those posts, and it shall not be necessary to take a poll for election to such post.
- (2) Where the number of contesting candidates for any post or category of post, in Form 6 is more than the number of posts to be filled, a poll shall be taken by secret ballot those posts remaining unfilled.
- (3) The ballot papers for these posts remaining unfilled shall be in Form 7 to Form 13 to be made individually for each post.
- (4) The names of contesting candidates on the ballot papers shall appear in the same order as in Form 6.

11. Poll:

- (3) The poll for the posts Remaining Unfilled under clause 9(2) above shall be taken post-wise, on 30.09.2018 at 2.00 pm and shall commence at during the SGM at the Agenda Item Elections, in Jaipur, Rajasthan.
- (4) Each contesting candidate can nominate one person, (If he/ she so desires,) Only from amongst the Authorized Representatives list of PCI, to be present at the poll (polling station).
- (5) At the poll, each authorized representative of Member District, who see name is included in the Electoral College list in Form 1, shall be entitled to –
- Cast one vote for each of the posts remaining unfilled, where only one such seat is to be filled;
- b. Cast as many votes as are the no. of seats to be filled for any posts, where more than one seat is to be filled.

Explanation: It is hereby clarified that for the purpose of filling four seats of Vice-Presidents, each voter can cost up to four votes, and, likewise, for four seats of Joint Secretaries, he/she can, cast four votes respectively for the above mentioned four seats of Joint Secretaries.

- (6) In case any voter casts his/her vote for more than one candidate, or for more than four candidates, as the case may be, his/her vote for that post shall be invalid.
- (7) Each voter shall be required, before he is supplied with a Ballot paper, to give his/her signature on the authenticated copy of the Electoral College list 1 used by the Returning Officer for taking the poll.
- (8) The voter shall record his/her vote on the ballot paper in secrecy in a voting compartment specially provided for the Purpose at the polling station.
- (9) The voter shall record his/her vote on the ballot paper by placing a tick mark (Right) against the name of the candidate of his/her choice, and any other mark, like (x) etc. or word, placed on the ballot paper by him/her shall render the ballot paper liable to rejection.
- (10) The tick mark (Right) to indicate the vote shall be placed by the voter only by means of article specifically provided for the purpose by the Returning Officer, and a ballot paper marked otherwise by mean of any pen, ball point pen, etc. by the voter shall render the ballot paper liable rejection.
- (11) The ballot paper marked by a voter shall be deposited by him/her in a ballot box specially prepared and sealed by the Returning Officer and placed at such a conspicuous place in the polling station that it shall be constantly visible to all present in the polling station.
- (12) The Returning Officer shall close the poll at the appointed hour; however, all those votes who are present at the polling station at the appointed closing hour shall be entitled to vote even if the poll proceedings have to be continued for some more time.
- (13) After all the votes referred to in sub-clause (9) have votes, the Returning Officer shall close the ballot box and shall not permit thereafter any person to vote.
- (14) Polling will be done below order:
 - 1. President
 - 2. Secretary
 - 3. Treasurer
 - 4. Vice-Presidents
 - 5. Joint-Secretaries

12. Counting of Votes:

- (1) The Returning Officer shall take up the counting of votes as soon as may be after the Polling for any post is complete.
- (2) Each contesting candidate can nominate one authorized representative (as clarified in S. No. 10 (2)) and His/she shall be present at the place of counting of votes.
- (3) The Returning Officer shall take up the counting of votes, post-wise and category wise, where applicable.
- (4) Each ballot paper on which a vote has been recorded in accordance with sub-clause (3) to (8) of clause (10) shall be treated as one vote for the candidate for whom it has Been validly marked; and if any ballot paper has been marked in violation of any of the aforesaid provisions of sub – clauses (3) to (8) of clause (10) shall be rejected by the Returning Officer.

- (5) The votes validly cast for each of the contesting candidates shall be counted postwise, and category-wise where applicable, and recorded in the descending order of the votes so cast for each candidate in Form 14.
- (6) The Returning Officer shall there after ascertain of counting and, subject to the provisions of Rule 4 (a) (II) of the Rules, the candidates who have secured the maximum no. of votes in the said descending order, post-wise and category wise, where applicable, equal to the no. of seats to be filled for each post or category of posts, where applicable, shall be deemed to have been duly elected to those posts.

13. Declaration of Results:

The names of contesting candidates who shall be deemed to have been elected at the election in accordance with sub-clause (6) of clause (11) shall be declared as having been duly elected to their respective posts, by the Returning Officer at the Special General Meeting (SGM) in the **Form 15**.
